Following are fees to be charged for services provided by the district courts. No fees are to be charged for services rendered on behalf of the United States, with the exception of those specifically prescribed in items 4(b), 4(e), and 4(f). No fees under this schedule shall be charged to federal agencies or programs which are funded from judiciary appropriations, including, but not limited to, agencies, organizations, and individuals providing services authorized by the Criminal Justice Act, 18 U.S.C. § 3006A, and Bankruptcy Administrator programs.

- a. New Civil Case (Complaint, Notice of Removal, Prisoner Civil Rights Complaint) . . . . . \$350.00
- b. Habeas Corpus Petition . . . . . \$5.00
- c. Cuban Liberty and Democratic Solidarity (LIBERTAD) Act 1996<sup>1</sup> . . . . . \$5,431.00

**2. APPEAL FILING FEE**

- a. Notice of Appeal<sup>2</sup> . . . . . \$455.00
- b. Appeal to District Judge from Conviction by US Magistrate Judge in a Misdemeanor or Petty Offense . . . . . \$32.00

**3. ATTORNEY ADMISSIONS FEES**

- a. Admission of Attorney to General Practice (New Application or Reinstatement) . . . . . \$200.00
- b. Special Admission - Pro Hac Vice . . . . . \$100.00

<sup>2</sup>Notice of Appeal fee includes both the District Court docket fee and the Appellate Court filing fee. One payment of \$455.00 per appeal should be tendered to the Clerk, United States District Court.

<sup>3</sup>This fee shall apply to services rendered on behalf of the United States if the information requested is available through electronic access.

For exemplification of any document or paper, twice the amount of the fee for certification. Stated fee does not include the \$0.50 per page reproduction fee. When remitting payment, please include the per-page document reproduction fee (as outlined in section 4(e) above) in addition to the standard fee for certifications and/or exemplifications.

<sup>5</sup>This fee shall apply to paper copies made from either: (1) original or electronic documents; or (2) microfiche or microfilm reproductions of the original records. This fee shall apply to services rendered on behalf of the United States if the record or paper requested is available through electronic access.

<sup>6</sup>For reproduction of recordings of proceedings, regardless of the medium, \$26, including the cost of the medium. This fee shall apply to services rendered on behalf of the United States, if the reproduction of the recording is available electronically.
