Does completing the QQ mean I will be a juror for sure?	No. If you are found qualified, you are eligible to serve as a juror between December 2021 and December 2023, but it is not guaranteed that you will be selected to serve. If you <i>are</i> selected to serve, you will receive a summons packet in the mail approximately four weeks before the trial date.
What if I do not know if my civil rights have been restored?	If you are not incarcerated, and you do not have pending felony charges, you are able to vote and serve on a jury. Information about restoration of voting rights can be found by looking up ORS 137.281.
Who can be disqualified?	 Fill out the QQ to request to be disqualified for the following reasons: Under 18 Not a U.S. Citizen Have not lived in Oregon for a minimum of one year Cannot read, write, and understand English well enough to complete the QQ unassisted Cannot speak English Cannot serve due to a physical or mental infirmity (complete the QQ now, send a doctor's letter by September 13) Have been convicted of a crime punishable by imprisonment of more than one year Have a charge pending for a crime punishable by imprisonment of more than one year
Who can be excused?	 Fill out the QQ to request to be excused for the following reasons: 70+ years old Full-time care providers and homeschoolers (children, elderly, infirm - not as an employed caregiver or teacher) Volunteer safety personnel (firefighters, rescue squads, etc.) Those who served jury duty between December 2019 and December 2021 (must provide proof of service)
Who is exempt?	 Fill out the QQ to request to be found exempt for the following reasons: Active service members of the U.S. Military (unless deployed, National Guard does not qualify) Full-time police offices (prison/jail guards and admin staff do not qualify) Full-time firefighters Full-time elected public officials
