## SURVEY OF SUBJECT MATTER EXPERTISE

Conflict resolution requires communication and mediation skills that help parties identify issues and interests, identify areas of common ground, allow parties to be heard, and envision creative solutions. Designate with a "2" those categories in which you have some experience. Designate with a "3" those categories in which you have little or no experience. Place an "X" next to any category of case, or speciality within a category, for which you would not wish to serve as a mediator.
