Court Personnel System Classification Level: CL 23 – CL 24

Salary Range \$35,811 - \$64,470 depending on experience, qualifications, and current compensation.
Promotion potential for a CL 23 to CL 24 at the discretion of the CUSPO without further competition.

THE POSITION

The United States Probation Office for the District of Oregon is accepting applications for a Probation Clerk in the **Portland** office. The incumbent provides specialized technical and administrative support to probation officers in a wide range of areas, including assisting with conducting investigations, compiling criminal histories, coordinating with collateral agencies, verifying information, processing administrative requests from officers, and assisting with miscellaneous DATS activities. More than one position may be filled with this announcement.

Representative Duties:

- Performs receptionist duties by greeting visitors/clients in person and on the telephone, answering routine questions, and directing visitors/callers to the appropriate person or department.
- Assists probation officers in compiling criminal histories, running record checks through local and national databases and files, conducting inquiries with collateral agencies, collecting verifiable and supportable documentation, and performing similar activities.
- Prepares and processes forms and documents, ensuring consistency and accuracy among reports, memorandums, and related paperwork. Obtains related records regarding offenders. Prepares and updates case files and officer field documents. Monitors officers' due dates and ensures officers' reports are provided to supervisors to meet deadlines. Tallies officers' completed investigations.
- Enters supervision data into the PACTS database, including fine, restitution, and fee assessment payments, contract and non-contract alcohol, drug and mental health treatment, and other special conditions of supervision. Analyzes the data in PACTS and corrects errors. Produces accurate data from the automated system including reports used by the officers, supervisors, and managers in monitoring caseload and workload statistics.
- Quality-checks all scanned documents to ensure each has been correctly uploaded and organized in the PACTS Document Imaging Module (PDIM).

- Assists in the training of new clerical personnel as directed by supervisor. Provides backup to other support staff.
- Screens incoming mail.
- Scans documents and completes general data entry as needed.
- Uploads documents in CM/ECF and verifies accuracy of all filings.
- Submits required documents to release centers, Bureau of Prisons, Parole Commission, and the U.S. Sentencing Commission.
- Other duties as assigned.

QUALIFICATIONS

Minimum Qualifications:

To qualify at CL 23, step 1, applicant must be a high school graduate or equivalent and have two years of general experience. To qualify at CL 23, step 2 or higher, applicant must have at least one year progressively responsible clerical or administrative experience requiring the regular and recurring application of clerical procedures that demonstrate the ability to apply a body of rules, regulations, directives, or laws and involve the routine use of specialized terminology and automated software and equipment for word processing, data entry or report generation. Such experience is commonly encountered in law firms, legal counsel offices, banking and credit firms, educational institutions, social service organizations, insurance companies, real estate and title offices, and corporate headquarters or human resources/payroll operations.

To qualify at CL 24, step 1, applicant must have one year of specialized experience equivalent to CL 23. To qualify at CL 24, step 2 or higher, applicant must have at least two years of specialized experience equivalent to CL 23.

Candidates must also demonstrate:

- A consistent past employment record;
- Experience in dealing with routine and complex assignments;
- A demonstrated ability to think through, analyze, and interpret written communications;
- Ability to prioritize tasks and work assignments;
- Superior oral and written communication skills;
- Strong interpersonal skills; and
- A professional demeanor and appearance appropriate for a law or professional office environment.

EMPLOYEE BENEFITS

Employees of the United States District Courts are not included in the Government's Civil Service classification. They are, however, entitled to the same benefits as other federal government employees. Some of these benefits are:

- Full-time employees accrue 13 days of paid vacation per year for the first 3 years of employment up to a maximum of 26 days per year at the 15-year anniversary.
- Participation in a retirement program with optional participation in the federal government's deferred compensation program, the Thrift Savings Plan. New employees entering Federal service on or after January 1, 2014, contribute 4.4% of their base pay to the FERS Basic Benefit plan throughout their career.
- Optional participation in a federal health insurance plan of choice.
- Optional participation in supplemental insurance programs, including group long-term care, group long-term disability insurance and dental and vision insurance.
- Optional participation in the flexible spending account program for unreimbursed medical, dental, and vision expenses; dependent care expenses; and commuter expenses.
- A minimum of 10 paid holidays per year.
- Time-in-service credit for employees of other federal agencies (some prior military service may qualify) for determining leave accrual and retirement benefits.

CONDITIONS OF EMPLOYMENT

- Employees of the United States Courts serve under "Excepted Appointments" and are considered "at will" employees. As such, employment can be terminated at any time. Furthermore, Federal Civil Service classifications do not apply.
- This position is subject to mandatory participation in electronic funds transfer (EFT) for payment of net pay (i.e., Direct Deposit). (Limited exceptions are available upon request.)
- Applicants must be United States citizens or lawful permanent residents currently seeking citizenship or intending to become a citizen after meeting the eligibility requirement as outlined in 8 U.S.C § 1324b(a)(3)(B).

The following conditions apply to candidates for positions with the United States District Court:

- False statements or omissions of information on any application materials or the inability to meet conditions of employment may be grounds for non-selection, withdrawal of an offer of employment, or dismissal after being employed.
- An FBI background check is required for all individuals appointed to positions in the US Probation Office. New employees are considered "provisional hires" pending the successful completion of the FBI background check.
